PARTNERSHIP REGULATIONS, 2009

STATUTORY INSTRUMENT NO

(In exercise of the powers conferred by section 52 of the Partnerships Act, 2008, the Minister of Legal Affairs and Constitutional Development hereby makes the following Regulations):

1. Short Title.

These Regulations may be cited as “The Partnership Regulations, 2009 and shall come into force upon publication in the Gazette”

2. Interpretation.

“Act” means the Partnership Act, 2008.

“dissolution” means

“Registrar” means the Registrar of Companies, NGOs, Societies and Associations;

3. Registration of firm under the Registration of Business Names Act.

- (1) Partners wishing to carry on business in Southern Sudan using a business name which consists of –
 - (a) any additions other than the true surnames of all the partners or the initials of such partners who are individuals; or
 - (b) the corporate names of all partners who are corporations, shall register that business name under section .. of the Registration of Business Names Act, 2008.
- (2) The certificate of registration shall be in Form of the Registration of Business Names Regulations, 2009.

4. Application for Registration of Partnership.

- (1) Where a partnership is registered under Regulation 3 of these Regulations, it may also register under the Act if the partners so decide.
- (2) Where the partners decide that their firm should register under the Act, the partners shall file a statement with the Registrar.
- (3) The statement for an application for registration of a partnership under section 6 and of the Act shall be in **Form 1** as specified in the First Schedule.

5. Certificate of Registration.

- (1) The Registrar shall upon receiving a statement for registration under section 6 of the Act, and Regulation 4 above, issue a certificate of registration which shall contain –
 - (a) the name of the partnership;
 - (b) the registration number allocated to the partnership; and
 - (c) the date of registration.
- (2) A certificate of registration shall be in **Form 2** in the First Schedule.
- (3) Every registered partnership shall display a copy of its certificate of registration in a conspicuous place in every place where the partnership carries on business.

6. Format of the Register.

- (1) The Registrar shall upon issuing a certificate under section 6 and Regulation 5 above, enter the particulars of the partnership in the Register of Partnerships.
- (2) The Register of Partnerships to be kept by the Register as provided under section 6 of the Act shall be in **Form 3** in the First Schedule.

7. Registered Partnership to Give Notice of Dissolution.

- (1) A registered partnership shall give the Registrar and the public notice of any dissolution of a partnership as required under Chapter V of the Act.
- (2) The notice in sub-regulation (1) of this Regulation shall specify cause of dissolution, surviving partners if any and nature of assets and liabilities if any and how they have been dealt with.
- (3) The notice to the Registrar referred to under sub-regulation (1) shall be in **Form 4** of the First Schedule to these Regulations.

(4) The notice to the public referred to under sub-regulation (1) shall be in **Form 5** of the First Schedule to these Regulations.

8. Notification of Intention to Terminate Partnership by one of the Partners.

A notice by a partner of a registered partnership to his or her partner(s) about intention to terminate the partnership under section 39 (c) of the Act shall give notice in **Form 6** of the First Schedule to these Regulations.

9. Notice of Death or Insolvency of Partner.

A notification of death, retirement or insolvency of a partner under Chapter V of the Act shall be in **Form 7** in the First Schedule to these Regulations.

10. Application to Court for Dissolution of a Partnership.

An application to court for dissolution of a partnership under section 42 of the Act shall be in accordance with the Civil Procedure Act, 2007.

11. Fees.

Fees to be paid under the Act are set out in the Second Schedule.
